



Risk Analysis

A key requirement of security standards and regulations such as HIPAA, HITECH, PCI DSS, NIST Cybersecurity Framework, ISO 27001, CCPA, GDPR and others is that organizations must conduct a comprehensive and thorough assessment of the potential risks and vulnerabilities to the Confidentiality, Integrity, and Availability (CIA) of all PII.

Organizations such as hospitals, health systems, physician practices, payers, dentists, as well as Business Associates must conduct a comprehensive Risk Analysis exercise to meet HIPAA mandates, including HITECH Meaningful Use requirements. Security standards such as NIST Cybersecurity Framework guideline require a thorough Risk Analysis.
